## 1. DESCRIPTION

The course presents the specific structural and phenomenological aspects of the various types of mafia operating at present times in Italy and internationally. It analyses contemporary criminal, social, cultural and political features of mafia-type groups, exploring traditional and emerging illegal markets. It describes main Italian and international law policies and legislations to contrast this type of organised crime and the experiences of leading individuals and groups developing a culture of legality to combat the mafia.

## 2. OBJECTIVE

The course aims at providing students with instruments of knowledge, comprehension, application, evaluation and synthesis on the topic by being able to:

- Define specific elements characterising mafia as compared to other criminal organisations
- Describe the relevance of key concepts like violence, death, honour, shame within mafia
- Identify contemporary illegal markets
- Explain the historical, economic, political and social elements of Italian mafia organisations
- Evaluate the relationships with religion and gender
- Indicate, analyse and compare the range of instruments and strategies to fight against the mafia
- Organise and present a research paper on a topic by choice -
- Enhance participation and constructive critical sense through class discussions

## 3. REQUIREMENTS

No specific background is required to attend this course.

Students are required to do the **readings** assigned. These readings provide the theoretical background for the topic concerned and are part of the material on which tests are based. You will find information on each lesson's readings on your lecture schedule.

You are **warmly invited to take notes in class** and do the readings on a weekly basis in order to be able to ask questions and have doubts clarified gradually: for the successful completion of the course students have to read the articles indicated in the syllabus and study all the further material that will be used in class during the semester.

**No eating or drinking is allowed in class:** food and beverages have to be consumed either during the breaks or before/after the class.

## At all times cell phones must be turned off.

A responsible and **active class participation** is expected at all times and activities. Please be aware that sleeping or napping is considered an inappropriate behaviour in class. After an initial warning, students may be asked to leave the class.

**Personal computers** are welcome for note taking, however, navigating social media or using the computer for personal reasons during class time is prohibited. The instructor will warn students of inappropriate computer use. Continued use of computers other than note taking may result in a lowered participation grade.

## 4. METHOD

The course uses different learning strategies: lectures, multimedia material, class discussions, structured working groups, written assignments and oral presentations.

Participation plays a role in your final grade and this means that in this course asking questions, making comments appropriate to the topics discussed and the capacity to draw personal conclusions of your own, are central aspects of the teacher's evaluation.

All video material, the related assignments and class discussions, constitute an integral part of course requirements and will be discussed during a given class period. In order for the discussions to be meaningful, each student must come to class fully prepared to discuss the assigned reading and to make meaningful comments.

## 11. EXAMS - PAPER

Note: be aware that the date and time of the exams cannot be changed for any reason so organise your personal schedule accordingly.

- Students are required to do the **assigned readings** for each lesson.
- **Home Assignments** aim at documenting your knowledge and understanding on specific aspects relating to the course topic and count for a **15%** of the final grade.

They have to be returned by the <u>beginning</u> of following class, printed or hand-written and they will be checked and discussed in class.

Please be aware that <u>late assignments will not be accepted</u> in any form and the related grade for that assignment will be F corresponding to 0 points. The text of the assignments is in the online course folder and the specific instructions will be given in class in their due time.

- There will be a **Midterm and a Final exam** consisting of essay and short questions on lectures and readings of the course-pack.

Format: both exams are divided in three sections:

Part I: Short-answer questions requiring students to answer with concise explanations of main ideas, key words and concepts, based on readings from the course-pack and lesson material;

Part II: Essay questions requiring a depth and width of analysis and not simply the description of factual occurrences.

Each correct and complete answer will be marked with the relevant points, summing up to 100 points in case of all perfect answers.

A complete answer consists in accurate and complete factual explanations, analysis or definitions, clear expression of personal opinions with appropriate language style, correct spelling and punctuation.

Part III - Matching questions, multiple choice, true/false questions

- Research Paper counts for a 20% of the final course grade.

The Research Paper is a **Group Research** (to be realised in small groups of at least 3 students that need to be formed and communicated to the instructor by Lesson 4.

Research is meant to discover information and explore ideas. The group work aims at stimulating creativity, the capacity to work well in teams and employing critical thinking skills.

Furthermore, it aims at assessing multiple viewpoints on potentially challenging juridical, historical or ethical issues. Working with teammates gives you the opportunity to consider and weigh alternative perspectives and opinions that you might not have considered working on your own.

The instructions for the Research Papers are in the attached course addendum.

The topic selected has to be communicated after the midterm break and see the addendum for the deadline of its submission. Research papers will be discussed in class.
