| Summary of module content: | | |
| This module provides an interdisciplinary perspective on sex, sexuality and gender in London from 1880 to the present. Taking approaches from history, sociology, law, politics and literature it covers topics such as Victorian sex scandals; the gendering of public space; masculinities and femininities; the impact of the law; Queer London; 'Women's Work'; the 'Swinging Sixties' and 'sexual liberation'; the making of cultures of sexuality in Soho and policing sexuality in Central London. | | |

Learning outcomes

On successful completion of this module the student will be able to:

• demonstrate command of a body of knowledge of sexual politics, identities, practices, law and cultural production in London between 1880 and the present;

- demonstrate an ability to research and reflect critically and contextually upon a range of contemporary texts and primary sources;
- demonstrate an understanding of the varieties of approaches to understanding the subjects of sexuality and gender, derived from the humanities, law and social sciences, and be able to apply interdisciplinary perspectives;
- demonstrate an awareness of continuity and change over extended time periods;
- achieve clarity, fluency and coherence in oral and written expression.

Teaching and learning methods

Seminars allow informal student-led discussion of the issues raised in reading, opportunities for supervised group work and practice in the key skills of interpretation and analysis of sources. The module will also make use of field walks to the West End and there will be an in-seminar workshop hosted by an NGO to facilitate students' understanding of some contemporary issues of sexism and homophobia.

Timetabled sessions will be supplemented by student reading and preparation for assignments. Reading and other study material will be suggested by the module team to assist students meet the module learning outcomes, and will include the provision of extracts from texts and/or journal articles with questions to guide and direct student engagement and outcomes.

Assessment rationale

This module is assessed by means of a portfolio.

The portfolio, contributed to weekly, allows students to record and evaluate the research and reading that they are undertaking. Specifically, it encourages them to consider the range of sources available and to analyse those sources critically in selecting weekly entries. The portfolio encourages reading across subjects and allows the student to develop a special focus of their own interest. The final entry will be a short critical reflection on an issue.

Assessment criteria

Detailed assessment criteria and guidance for both elements will be found on the Blackboard site for the module.

A formative assessment of the portfolio will take place in weeks 3 and 7 and feedback will be given.

In general terms the portfolio will be assessed according to how well the student's weekly entries engage with the topics, and how far they demonstrate a good range of research. Weekly entries (minimum 9) are expected to be at least 300-500 words and to be drawn from different fields (e.g. news media, critical essays, historical documents, blogs, fiction, legal sources).
